Child Custody Evaluators are also required to file a *Declaration of Private Child Custody Evaluator Regarding Qualifications* with the court within 10 days of being appointed to a case and prior to beginning work on a case, in accordance with the California Rules of Court rules 5.225 and 5.230, and Family Code Sections 1816 and 3110.5.
