

1 3. The records subject to this order are those health and education records of youths
2 currently subject to the jurisdiction of the Riverside County Juvenile Court. The following types
3 of information shall be made available for the purposes of the Foster Focus program: health and
4 education summaries for youth placed in foster care, foster care home placement details
5 including name, address, and phone number, youth demographics, assigned Children's Services
6 staff, and juvenile court case number.

7 4. Copies of this order shall be distributed to:

- 8 a) Riverside County Department of Public Social Services;
- 9 b) Riverside County Probation Department, Juvenile Division;
- 10 c) Riverside County Office of Education;
- 11 d) Riverside County Department of Mental Health;
- 12 e) All school districts within Riverside County;
- 13 f) All directors of Special Education Local Plan Area in Riverside County;
- 14 g) All private and non-public schools in Riverside County;
- 15 h) All other educational institutions serving foster youth in Riverside County;
- 16 i) All foster care providers and foster family agencies in Riverside County;
- 17 j) All group home providers utilized by Riverside County;
- 18 k) All health agencies and immunization registry;
- 19 l) All attorneys representing clients in juvenile court proceedings;
- 20 m) All out-of-county Foster Focus Coordinators; and
- 21 n) All out-of-county providers serving Riverside County wards and dependents.

23 4. Foster Focus representatives may share information from the database with the above-
24 listed persons and agencies if:

- 25 a) Such disclosure will be in the best interests of the youth whose records are sought; and
- 26 b) The information contained in those records is necessary and relevant to the provision
27 of services to the youth.

1 5. The information subject to this order may be transmitted electronically if Petitioner
2 Foster Focus establishes a method of electronic transmission that ensures the information will be
3 kept confidential.

4 6. Any person or agency receiving records and/or information pursuant to this order shall
5 maintain the confidentiality of such records and information and shall use them only to the extent
6 necessary for the Foster Focus program.


7 7. The Riverside County Office of Education Foster Focus Service Unit shall bear the
8 responsibility of providing a copy of this order, upon request, to persons and agencies involved
9 in the Foster Focus program.

10 8. Any unauthorized disclosure of confidential information or any failure to comply with
11 the terms of this order may result in this order being vacated and/or may be punishable as
12 contempt of court.

13 9. This order is not intended to replace, nullify, or conflict with any existing policies of
14 the Department of Public Social Services, the Probation Department, Riverside County Mental
15 Health, or any other public or private agency.
