You may fax file the Notice of Appeal form and all subsequent documents directly to the Appeals Department at no the charge. This method is strongly recommended to ensure the quickest processing and to avoid errors and delays. A free file stamped copy of the documents will be returned to you if you fax file. You may also bring or mail the Notice of Appeal form and subsequent documents to the Appeals Department located at the Hall of Justice, 4100 Main Street, Riverside, CA 92501 for filing. Alternatively, these documents may also be filed at any courthouse within Riverside County. If you do not fax file and you would like a file stamped copy of the documents you are submitting, you must supply an extra copy to be returned to you. If you would like the copy mailed to you, you must also provide an envelope and correct postage.
