No withdrawals of principal or interest shall be made from the blocked account or accounts without a written order under this case name and number, signed by a judge, and bearing the seal of this court, until the minor attains the age of 18 years. When the minor attains the age of 18 years, the depository, without further order of this court, is authorized and directed to pay by check or draft to the former minor, upon proper demand, all money's including interest deposited under this petition. The money on deposit is not subject to escheat.
2. Deliver a copy of the order on this petition (Judicial Council Form MC-355) to each depository in which funds are deposited under this petition, and file the depository's acknowledgement of receipt of the order and the funds (Judicial Council Form MC-356) with this court within 15 days of deposit.
