**I AGREE TO ALL OF THE FOLLOWING CONDITIONS OF A RELEASE ON MY OWN RECOGNIZANCE:**

1. I will obey all conditions imposed by the court.

3. I understand that if I fail to appear for trial as ordered, the trial may go forward in my absence. Should this occur, and if I am found guilty of committing the charge(s), fines/fees will consequently be imposed and I will be given a pay-by date 30 days from the date of entry of judgment. In the event the court does not receive payment on or before this date, I understand a failure to pay civil assessment may be imposed in addition to the fine amount. I also understand the Department of Motor Vehicles will be notified of any judgment of conviction, which may result in points being noted on my driving record.
4. I will appear in person for the arraignment set in this matter on \_\_\_\_\_ at \_\_\_\_\_ in Department \_\_\_\_\_ at the \_\_\_\_\_ Court, and at all times and places ordered by the court and as ordered by any court in which the charge or charges are pending.
5. I will not depart this state without leave of the court, and I waive extradition if I fail to appear as required and am apprehended outside of the State of California.
6. The court may revoke the order for my release on my own recognizance, at its discretion, require that I give bail or other assurance for my appearance; and
7. I promise to obey the following additional conditions of my release, and all other reasonable conditions imposed by the court or magistrate.
