## Information Collected and Stored

For each visitor to our website, our web server automatically gathers and stores certain information. Only the following information is collected and stored:

- Your internet domain and IP address. The Internet Protocol Address is a numerical identifier assigned either to your internet service provider or directly to your computer.
- The type of browser and operating system you used to access our site.
- The date and time of your access to our site.

## How This Information Is Used
