2025 Felony & Misdemeanor Bail Schedule

In determining release or setting of bail, the judicial officer will review the following factors when setting any amount of bail (Penal Code §1275(a); California Constitution Article 1, §§12, 28(b)(3)):

- Safety of the victim;
- Safety of the victim's family;
- Seriousness of the offense(s) charged;
- Defendant's criminal record;
- Protection of the public (primary consideration); and
- Probability of defendant returning to court.

Phases of Implementation

The Riverside County Superior Court adopts this bail schedule effective **October 24, 2025**. The bail schedule will be implemented in two phases.

Phase 1: Effective **October 24, 2025** all bail amounts listed should be followed and the Riverside County Sheriff's Office is authorized to release with a signed promise to appear any person charged with a crime marked Cite and Release (CR) and Book and Release (BR). For all other offenses the RSO may continue to accept bail.

Phase 2: The Riverside County Superior Court will implement a process for Pre-Arrestment Review for crimes designated PAR. This date is to be determined.

Note: This Felony & Misdemeanor Bail Schedule is not for mandatory use in setting bail where a warrant is issued. In such cases, bail shall be set in accordance with the principles set forth in 1275 P.C. and lies within the sound discretion of the magistrate.

BAIL SCHEDULE AND RELEASE PROTOCOL

All offenses will fall within one of four categories:

CR - Cite and Release

BR – Book and Release

PAR – Pre-Arrestment Review

AR – Arrestment Review

The release protocol for each crime will be designated in the Bail Schedule in a column titled “Offense Category.”

Definitions

Cite and Release (CR): People arrested for crimes designated as CR with no offense category exception are not required to post bail. Arrestees must sign a promise to appear in court as required by Penal Code section 1318.

Book and Release (BR): People arrested for crimes designated as BR with no offense category exception are not required to post bail. Arrestees must sign a promise to appear in court for arraignment as required by Penal Code section 1318 and must be booked by the arresting agency.

Pre-Arrestment Review (PAR): People arrested for crimes designated as PAR will have bail set in the scheduled amount. The arrestee may post bail at any time. An arrestee who has not paid bail according to the schedule will be afforded a review of bail and custody status by a magistrate in accordance with Penal Code 1275 prior to arraignment.

Note: Ability to offer Pre-Arrestment Review is contingent upon implementation of the Case Management System Integration for Public Safety Assessment Parsing data exchange, which will populate Pretrial Risk Assessment Reports prior to arraignment. This technology will be implemented at a future date to be determined. Until such time as that technology is implemented, crimes designated as PAR are treated as AR.

Arrestment Review (AR): People arrested for crimes designated as AR will have bail set in the scheduled amount. The arrestee may post bail at any time. At the time of arraignment, bail amount and custody status will be reviewed by a judicial officer pursuant to Penal Code 1275.

BAIL SCHEDULE AND RELEASE PROTOCOL RULES

Rule 1: Setting Bail

A. Bail for felony crimes will be set as follows:

1. The amount set in the approved arrest warrant;
2. The amount set pursuant to Penal Code 1269c (see Rule 6(A) herein);
3. The amount set at a hearing in court; and/or
4. The amount set through use of this Bail Schedule.

B. To calculate bail on any one case, take the count that imposes the longest term of incarceration, find the offense category and (if applicable) the bail amount from the relevant Bail Schedule section. Confirm there is no exception to the offense category set forth in these Rules. Next, add bail for all applicable enhancements.

Rule 2: Multiple Cases

A. Multiple Counts in a Single Case: If an individual is arrested on two or more counts with different offense categories designated herein, the strictest offense category applicable to the arrestee's alleged offenses determines the release protocol for that arrestee.

B. Multiple Cases: Determine the offense category and, if applicable, the bail amount, for each case separately, including all applicable enhancements. A separate determination is required for each separate case.

Rule 3: Offense Category Exceptions

CR and BR offense categories do not apply if other factors exist. Other factors include a prior failure to appear or other holds apart from the current arrest, which would prohibit release. If other factors exist, the arresting agency should advise what other factor(s) exist with respect to an arrestee. Upon advisement that other factors exist, the offense category changes to PAR.

Rule 4: Enhancements/Strikes

A. Enhancements

The bail amount specifically described for each applicable enhancement shall be added cumulatively to the bail (if any) set forth for the specified offense.

B. Strikes

Where it is alleged in the Complaint or Information, or it is evident from other information made available to the Court, that there is a strike prior within the meaning of Penal Code Sections 667 and 1170.12, additional bail shall be calculated per the Priors & Sentencing Enhancement section of this Bail Schedule.

Rule 5: Unlisted Offenses

A. Unlisted Felonies/Enhancements

All felonies not listed in this bail schedule have an offense category of PAR. Presumptive bail is set at the middle term multiplied by \$10,000. All enhancements not listed in this bail schedule have an offense category that is the same as the underlying offense. Presumptive bail is set at the term of the enhancement multiplied by \$10,000 or the middle term of the enhancement, if one is provided, times \$10,000.

B. Unlisted Attempts

Any attempt under Penal Code 664(a) that is not specifically listed in the bail schedule falls under the same offense category as the completed crime. The presumptive bail amount for such attempts is one half (1/2) the amount of the completed crime set forth in this bail schedule.

C. Unlisted Misdemeanors

All misdemeanors not listed in this bail schedule have an offense category of CR. Unlisted misdemeanors with a sentencing range of 180 days or less have a presumptive bail amount of \$2,500. Unlisted misdemeanors with a sentencing range of 181+ days have a presumptive bail amount of \$5,000.

Rule 6: Bail Deviations/Source of Bail Funds

A. Bail Deviations (1269c P.C.)

In the event that a magistrate approves a bail deviation per 1269c P.C., any magistrate approved form must be filed with the Complaint.

B. Source of Bail Funds (1275.1 P.C.)

In the event that a magistrate approves an application per 1275.1 P.C., the approved form must be filed with the Complaint or filed with the court if the complaint has already been filed.

Rule 7: Reproductive Rights

Pursuant to Penal Code section 1269b(f)(2), any person arrested in California in connection with a proceeding in another state regarding an individual performing, supporting, or aiding in the performance of an abortion in California, or an individual obtaining an abortion in California, if the abortion is lawful under the laws of this State shall not be held in custody and shall be immediately released on \$0 bail.
