

## PROFESSIONAL SUPERVISED VISITATION PROVIDERS 2026

According to Family Code Section 3200, all providers of supervised visitation **must** operate their programs in compliance with the “Uniform Standards of Practice for Providers of Supervised Visitation” which can be found in the California Rules of Court, Standards of Judicial Administration, [California Rules of Court: Standards of Judicial Administration Standard 5.20](#). Therefore, when selecting one of the following supervised visitations monitors it is very important that you, as parents, be familiar with the Standards of Practice and use good judgment when selecting any monitor.

**Each provider on the list must register with TrustLine.** [TrustLine](#) requires all caregivers listed on its registry to pass a background screening that qualifies them to be a childcare provider. All persons listed on TrustLine have been cleared through a fingerprint check of records at the California Department of Justice and have no disqualifying criminal convictions or substantiated child abuse reports in California that would prevent them from being a childcare provider. As a monitor may be spending some time alone with your child, it is wise to select a monitor that is registered. It is your responsibility as a parent, to verify that the monitor is actually registered by calling 1-800-822-8490.
