

## INFORMATION SHEET ON PERSONALIZED LIST OF RIGHTS

This is an information sheet to help you fill out Riverside County Local Form RI-PR105, Personalized List of Rights.

### **The Purpose of This Form**

Probate Code 1835.5 requires conservatees to be provided with a list of their rights, and any rights that were withheld by the court.

This form must be completed by the conservator.

### **When to Complete This Form**

The conservator must complete and file this form at the following times:

- When a petition is filed that requests an order that will change the rights of the proposed conservatee or conservatee
- Within 30 days after an order is made that changes the rights of the proposed conservatee or conservatee (if a correct form was not already filed)
- Within 30 days after the court enters an Order Appointing Court Investigator (if correct form was not already filed).

Orders that change the rights of the proposed conservatee or conservatee include the following:

- An Order Appointing Probate Conservator (form GC-340)
- An Order Authorizing Conservator to Give Consent for Medical Treatment (form GC-385)
- An order modifying the voting capacity of the conservatee under Elections Code 2208
- An order modifying the contractual capacity of a conservatee under Probate Code 1873
- An order determining the capacity of a conservatee to marry or enter into a registered domestic partnership under Probate Code 1901
- An order limiting the powers of a conservator under Probate Code 2350 (person) or 2450 (estate)
- An order limiting the conservatee's right to receive visitors, telephone calls, and personal mail under Probate Code 2351(a)
- An order that the conservator obtain and/or consent to specified medical treatment to be performed on the conservatee under Probate Code 2357
- An order directing the conservator to receive wages of the conservatee under Probate Code 2601.

### **How to Complete This Form**

Separate Instructions are provided for conservatorship and limited conservatorship. Please look carefully at your Order Appointing Probate Conservator (form GC-340) to follow the appropriate instructions below.

#### **Conservatorship**

If you have a conservatorship (not a limited conservatorship), the following instructions will guide you in completing the three portions of the form: Personal Rights, Estate Rights, and Other Rights.

**Personal Rights**

Separate instructions for completing the “personal rights” are provided below for two situations: (1) no conservator of the person has been appointed, or (2) a conservator of the person has been appointed.

*No Conservator of the Person*

If no conservator of the person has been appointed, check the box for “yes” for each of the eight “personal rights:”

*Box 22 or 23*

If box 22 or 23 are checked on the Order Appointing Probate Conservator (form GC-340), mark the box “no” for the corresponding right on RI-PR105, as indicated in the table below.

*Box 25*

Box 25 on the Order Appointing Probate Conservator (form GC-340) can be used for two purposes: the right to marry or enter into a domestic partnership, or the right to enter into business transactions.

If attachment 25 finds the conservatee has capacity to marry or enter a domestic partnership or it does not refer to the capacity to marry or enter a domestic partnership, check the box “yes.”

If attachment 25 finds the conservatee does not have capacity to marry or enter a domestic partnership, check the box “no.”

*Box 26*

Box 26 on the Order Appointing Probate Conservator (form GC-340) can be used either to increase the personal rights of the conservatee, or to limit those rights.

If attachment 26 gives the conservator the rights to make *all* decisions concerning either of the following two rights, then check the box “no” for that right. If it gives both the conservator and the conservatee the right to make *some* decisions concerning one of the rights, then check the box “changed” for that right and copy the contents of attachment 26 into the “other rights” section of the form:

- Receive personal mail.
- Receive visits from family and friends.

If attachment 26 gives the conservatee the right to make *all* decisions concerning one of the following three rights, then check the box “yes” for that right. If it gives both the conservator and the conservatee the right to make *some* decisions concerning one of the rights, then check the box “changed” for that right and copy the contents of attachment 26 into the “other rights” section of the form:

- Select your residence
- Access your confidential records and papers
- Make your own educational decisions

**Estate Rights**

Separate instructions for completing the “estate rights” are provided below for two situations: (1) no conservator of the estate has been appointed, or (2) a conservator of the estate has been appointed.

*No Conservator of the Estate*

If no conservator of the estate has been appointed, all of the boxes in the “Estate Rights” section should be marked “yes:”

### Conservator of the Estate

If a conservator of the estate has been appointed, if box 25 and 29 are not checked in the Order Appointing Probate Conservator form GC-340) then mark the first box “yes,” and the remaining four boxes “no.”

If boxes 25 or 29 are checked, follow the directions below. If these directions do not give guidance as to a right, complete the box for that right as indicated above

#### Box 25 – Business Transactions

Box 25 on the Order Appointing Probate Conservator (form GC-340) can be used for two purposes: the right to marry or enter a domestic partnership, or the right to enter into business transactions.

If attachment 25 finds the conservatee has capacity to enter into all business transactions, then check the box “yes” for this right. If it finds the conservatee has capacity to enter into some business transactions, then check the box “changed” for this right and copy the contents of attachment 25 into the “other rights” section of the form.

#### Box 29

Box 29 on the Order Appointing Probate Conservator (form GC-340) can be used for any order. This could include an order increasing the estate rights of the conservatee, or limiting those rights.

#### Wages

If attachment 29 gives the conservator authority to control *all* wages of the conservatee, then check the box “no” for that right. If it gives the conservator authority to control some of the wages of the conservatee, then check the box “changed” for that right and copy the contents of attachment 29 into the “other rights” section of the form.

#### Other Estate Rights

If attachment 29 gives the conservatee the right to make *all* decisions concerning one of the following four rights, then check the box “yes” for that right. If it gives both the conservator and the conservatee the right to make *some* decisions concerning one of the rights, then check the box “changed” for that right and copy the contents of attachment 29 into the “other rights” section of the form:

- Enter into business transactions
- Possess and manage your property
- Collect, manage, and litigate your rentals, and other claims against others
- Pay, compromise, or defend claims against you

For example, if attachment 29 makes an order for the conservator to pay a monthly allowance to the conservatee then the box “changed” for “possess and manage your property” should be checked, and the contents of attachment 29 should be copied into the “other rights” section of the form.

### *Other Rights*

The “other rights” section of the form provides information in two situations: (1) when the box “changed” is selected for a personal right or an estate right, and (2) when a court order creates an additional right that is not listed on the form.

### *“Changed” Rights*

If the box “changed” was checked for any of the personal rights or estate rights, you must copy into the “other rights” section of the form what is written in the court order concerning this right.

### *Box 26 – Additional Personal Right*

Item 26 of the Order Appointing Probate Conservator (form GC-340) can be used for many purposes, including an order under Probate Code 2358 creating a new personal right for the conservatee. If item 26 is checked and attachment 26 creates a new personal right that is not already on the form, the contents of attachment 26 should be copied into the “other rights” section of the form.

### *Box 27 – Additional Estate Right*

If item 27 of the Order Appointing Probate Conservator (form GC-340) is checked, copy the contents of attachment 27 into the “other rights” section of the form.

## **Limited Conservatorship**

If you have a limited conservatorship (not a limited conservatorship), the following instructions will guide you in completing the three portions of the form: Personal Rights, Estate Rights, and Other Rights.

### **Personal Rights**

Separate instructions for completing the “personal rights” are provided below for two situations: (1) no limited conservator of the person has been appointed, or (2) a limited conservator of the person has been appointed.

#### *No Limited Conservator of the Person*

If no limited conservator of the person has been appointed, check the box for “yes” for each of the eight “personal rights:”

*Limited Conservator of the Person*

If a limited conservator of the person has been appointed, see if any of the following boxes are checked on the Order Appointing Probate Conservator (form GC-340)

- Attachments 31, 32, and 33 (form RI-PR062), focusing only on the column labeled “Conservatee’s Right Limited:”

If none of these boxes is checked, then check the box for “yes” for all eight “personal rights,” as indicated above.

If any of these boxes is checked, follow the directions below. If these directions do not give guidance as to a right, complete the “yes” box for that right, as indicated above.

*Box 22 or 23*

If box 22 or 23 are checked on the GC-340, follow the directions in the following table:

*Box 25*

Box 25 on the Order Appointing Probate Conservator (form GC-340) can be used for two purposes: the right to marry or enter a domestic partnership, or the right to enter into business transactions.

If attachment 25 finds the conservatee has capacity to marry or enter a domestic partnership, check the box “yes” for “Marry or enter into a registered domestic partnership.”

If attachment 25 finds the conservatee does not have capacity to marry or enter a domestic partnership, check the box “no.”

If attachment 25 does not refer to the capacity to marry or enter a domestic partnership, see if item 3 of Attachments 31, 32, and 33 (form RI-PR062) has the box checked for “Conservatee’s Right Limited.” If this box is checked, check the box “no” for “Marry or enter into a registered domestic partnership.” If this box is not checked, check the box “yes.”

*Box 26*

Box 26 on the Order Appointing Probate Conservator (form GC-340) can be used either to increase the personal rights of the conservatee, or to limit those rights.

If attachment 26 gives the conservator the right to make *all* decisions concerning any of the personal rights, then check the box “no” for that right. If it gives both the conservator and the conservatee the right to make *some* decisions concerning one of the rights, then check the box “changed” for that right and copy the contents of attachment 26 into the “other rights” section of the form.

*Items 1, 2, 3, 5, 6, or 7 of Attachments 31, 32, and 33 (form RI-PR062)*

If the box “Conservatee’s Right Limited” is checked for boxes 1, 2, 3, 5, 6, or 7 of Attachments 31, 32, and 33 (form RI-PR062), follow the directions in the following table:

*Item 8 of Attachment 31, 32, and 33 (form RI-PR062)*

If box 8 is checked of Attachments 31, 32, and 33 (form RI-PR062), copy the contents of sub-attachment 8 into the “other rights” section of the form.

**Estate Rights**

Separate instructions for completing the “estate rights” are provided below for two situations: (1) no limited conservator of the estate has been appointed, or (2) a limited conservator of the estate has been appointed.

*No Limited Conservator of the Estate*

If no limited conservator of the estate has been appointed, all of the boxes in the “Estate Rights” section should be marked “yes.” However, if the court limited the contractual authority of the limited conservatee by checking the “Conservatee’s Right Limited” box on item 4 of Attachments 31, 32, and 33 (form RI-PR062), then the “business transactions” box should be marked “no.”

*Limited Conservator of the Estate*

If a limited conservator of the estate has been appointed, check the “yes” box for all of the rights unless one of the following applies:

*Items 9, 11, or 12 of Attachments 31, 32, and 33 (form RI-PR062)*

If the box “Conservatee’s Right Limited” is checked for item 9, 11, or 12 of Attachments 31, 32, and 33 (form RI-PR062), then use the following table to select the box for the corresponding right. If the box “all” in RI-PR062 is also checked, then check the box “No” on RI-PR105. If instead the box “only the...” box in RI-PR062 is also checked, then check the box “Changed” on RI-PR105, and copy the contents of the sub-attachment into the “other rights” section of the form:

*Item 10 of Attachments 31, 32, and 33 (form RI-PR062)*

If the boxes "Conservatee's Right Limited" and "all" are checked for item 10 of Attachments 31, 32, and 33 (form RI-PR062), then check the boxes "no" for both of the following rights:

- Directly receive and control your wages
- Collect, manage, and litigate rentals, and other claims against others

If the box "all" is not checked, but instead the box "only the..." is checked, review sub-attachment 10.

*Wages*

If sub-attachment 10 gives the conservator the right to make *all* decisions concerning wages, then check the box "no" for "Directly receive and control your wages." If it gives both the conservator and the conservatee the right to make *some* decisions concerning wages, then check the box "changed" for that right and copy the contents of sub-attachment 10 into the "other rights" section of the form.

*Rentals and Other Claims*

If sub-attachment 10 gives the conservator the right to make *all* decisions concerning rentals and other claims, then check the box "no" for "Collect, manage, and litigate your rentals, and other claims against others." If it gives both the conservator and the conservatee the right to make *some* decisions concerning rentals and other claims, then check the box "changed" for that right and copy the contents of sub-attachment 10 into the "other rights" section of the form.

*Item 13 of Attachments 31, 32, and 33 (form RI-PR062)*

If box 13 is checked of Attachments 31, 32, and 33 (form RI-PR062), copy the contents of sub-attachment 13 into the "other rights" section of the form.

*Other Rights*

The "other rights" section of the form provides information in two situations: (1) when the box "changed" is selected for a personal right or an estate right, and (2) when a court order creates an additional right that is not listed on the form.

*"Changed" Rights*

If the box "changed" was checked for any of the personal rights or estate rights, you must copy into the "other rights" section of the form what is written in the court order concerning this right.

*Box 26 – Additional Personal Right*

Item 26 of the Order Appointing Probate Conservator (form GC-340) can be used for many purposes, including an order under Probate Code 2358 creating a new personal right for the conservatee. If item 26 is checked and attachment 26 creates a new personal right that is not already on the form, the contents of attachment 26 should be copied into the "other rights" section of the form.

*Box 27 – Additional Estate Right*

If item 27 of the Order Appointing Probate Conservator (form GC-340) is checked, copy the contents of attachment 27 into the "other rights" section of the form.
