The appointment of the conservator may also take away some or all of the following rights: The right to refuse treatment related to your being gravely disabled; The right to refuse routine medical treatment; The ability to possess a driver's license or to operate a motor vehicle; The right to enter into contracts; The right to vote; The right to possess a firearm. You have a right to appear at the hearing and oppose the petition. You have the right to hire an attorney of your choice to represent you. The court will appoint an attorney to represent you if you are unable to retain one. You must pay
