Explanation: Granting a right to a conservator gives the conservator power equal to the conservatee. If the conservatee’s right **is not** limited, then the conservatee may exercise the right without the consent of the conservator or may override the consent of the conservator.

If the conservatee’s right is limited, then the consent of the conservator alone is sufficient whether or not the conservatee objects.
